# **April Meetings Will Take Consensus Based Upon Local Policy Study**

The April 19 and 20 unit meetings of the Roseville Area League of Women Voters will take consensus on the issues raised by the recently-completed year-long study of police services provided in Roseville, Maplewood, Little Canada, Falcon Heights and Lauderdale. The consensus process is the method used by the League at all levels to develop official positions that are the basis for advocacy and support. Consensus positions adopted by the Roseville Area LWV based upon this study, if any, will serve as the basis to advocate to the city councils.

Before the April 19 -20 meetings, each League member will receive a copy of the final report, which includes the potential consensus positions. At the meetings, there will be a presen-

tation on the study, followed by discussion and voting on the consensus positions. Agreed upon consensus positions become official positions of our local League, subject only to vote of the members at the annual or other all-League meeting. To get the most out of the consensus process, members should read the report and consider the consensus positions before the meeting.

Eureka Recycling processes over 200 tons per day at their single sort Material Recovery Facility (MRF) in Minneapolis. This starts with the mix of recyclables and ends with 17 different types of materials which leave the facility ready for production into new materials.

Roseville has a three-year contract with Eureka Recycling. Eureka has processed recyclables from St Paul for 15 years and recently signed a five- year contract with the City of Minneapolis. Lauderdale's recyclables as well as White Bear Lake's are other communities in our area using this facility.

#### An Oft-Overlooked Gem

Just a few blocks from the Cathedral of St. Paul lies an oft-overlooked gem: the Penumbra Theatre, founded in 1976 by Lou Bellamy as a part of the Black Arts Movement. He sought "to create a forum for African-American voices in the Twin Cities' well-respected theater community." It is located in the same complex as the Hallie Q. Brown Community Center and the Martin Luther King Recreation Center, just a few blocks from the upscale bars and restaurants on Selby Avenue, and the wealth of ethnic restaurants on University Avenue. Yet, tucked in a residential neighborhood, it is too often unnoticed by too much of the community. Forty years of thoughtful and thought provoking theater is a lot to miss out on. We are so fortunate to have one of only three professional African American theaters in the country offering a full season of performances, a place which has nurtured the careers of playwrights and actors, fed the soul of a community and won awards along the way. https://penumbratheatre.org/history/

This season the Penumbra Theatre offers entertaining and challenging plays and so much more under the theme of Revolution Love.

On a tight budget? Check out the REEL Talk series. This film series is free, just reserve your seat and show up for films touching on race in America from a variety of perspectives, followed by guided discussion. Last year I took a group of teachers to see "Dark Girls," a documentary about colorism. This year we saw "Anne Braden: Southern Patriot," a biography of a white ally to the Civil Rights movement. One resource connected to the film about Anne Braden is her "Letter to White Southern Women." http://annebradenfilm.org/assets/files/BradenLetter.pdf This letter entreats white women to recognize how the rules and biases that put them on a pedestal also keep them infantilized and limited and they are used by the system to restrict, intimidate and punish African Americans. Be an ally and read her impassioned plea. Still to come this spring are films about Angela Davis and about black LGBTQ youth. Such a deal you should not pass up.

A theatre lover? Add some of their plays to your schedule. You may know that the Twin Cities has a vibrant and diverse theater scene, with "nearly 100 theater companies, more than 30 venues and more theater seats per capita than anywhere outside of New York."

www1.umn.edu/wishyouwerehere/artsandculture/theatersce ne.html It is impossible to attend performances at all of them, so I am putting in a plug for this one. There are others that explore non-white topics, plays and playwrights, like Theater Mu and the Mixed Blood Theater, so a theater goer need never be limited to the white writer classics. Try them all. Start small and then try more.

Looking for insight into current events? The Penumbra Theatre also sponsors panel discussions and speakers. The Let's Talk series facilitated by Co-artistic Director Sarah Bellamy begins with refreshments and a social time followed by a 90 program with discussion. An upcoming event in this series includes Bobby Seale, co-founder of the Black Panthers. It has generated so much interest that it has been moved to a larger venue at the University. If you miss these programs live, they are sometimes repeated on MPR. For example you can listen to the "On the Front Lines" discussion about race from September at www.mprnews.org/story/2015/09/24/mpr\_news\_presents (MPR is a place where you can find all sorts of informative talks!)

This is a theater with a mission to "create professional productions that are artistically excellent, thought provoking and relevant, and illuminate the human condition through the prism of the African American experience." This is a prism too often lacking in the consciousness and experience of the white theater-going audience. Minnesota is incredibly blessed to have this resource. Among Penumbra's enumerated goals is a drive "[t]o use theatre to create an American mythology that includes African Americans and other peoples of color in every thread of the fabric of our society." This is what we all need in order to live together more peaceably and respectfully. The Penumbra Theater also has educational programs for youth curricular materials for teachers, race workshops a

youth, curricular materials for teachers, race workshops, a speakers' bureau and more. It is a place for growth for all segments of the community.

Recently I attended a pair of challenging one act plays at the Penumbra Theatre, Dutchman and The Owl Answers, and in the study guide it says--"At Penumbra,
