# **Study Consensus: Equitable Representation in City Commissions and Boards**

As the study for the Equitable Representation in City Commissions and Boards wraps up, our League needs to reach a consensus to allow for potential advocacy. To do this a Zoom meeting will be held on **Monday**,

May 24 at 7 p.m. We do not anticipate this being a long meeting, however, it will give the study committee an opportunity to present the research and suggestions made by



city participants. After comments and questions, League members will have the opportunity to vote on the following question:

Should LWV of Roseville Area recommend that our cities' boards and commissions broadly reflect the diversity of their population, including race, ethnicity, gender, income, age, and other aspects of diversity?

The goal of this year-long study was to identify current practices and suggestions and/or best practices in equitable representation for boards and commissions appointed by the city councils of Falcon Heights, Lauderdale, Little Canada, Maplewood, and Roseville. ### **Insects and Climate Change**

Please join us **June 15 at 7 p.m.** for a presentation on bugs, climate change, and the forests of Minnesota, with Dr. Brian Aukema, UMN Entomologist. Dr. Aukema likes trees, and spends most of his time trying to figure out why insects are eating them.

Of a Larch Life Well Lived: How a Changing Climate is Facilitating Outbreaks of Tree-Killing Insects will detail stories about the unexpected discovery that this insect—and others—are taking advantage of a changing climate to create unprecedented new challenges in natural resource management. Of particular importance to Minnesota are the Tamarack trees in our bogs now challenged by tree-killing eastern larch beetles. Dr. Aukema, who oversees the UMN Forest Insect Ecology, will detail research on a variety of forest insect challenges of consequence to the state and region, many of which are impacted by facets of global change such as climate change and invasive species.

This event is the second in a series on climate change and the forests of Minnesota. The webinar will be presented through the Ramsey County Library. The presentation is co-hosted with Resilient Roseville, a local climate action group, and with Do-Good-Roseville.

Thank you to all those who were able to attend the virtual business portion of our Annual Meeting. Membership approved the Budget Committee's recommendation for the new fiscal year, the slate of Board members presented by the Nominating Committee, and amendments to our Policies and Procedures as requested by the Board. In addition, membership re-adopted our local Program for Action, with a change to one position, substituting resident for citizen. Having heard updates on study progress from our two committees, membership also approved continuation of the studies into the new year. A lively discussion resulted from directions to the Board. In spite of the pandemic impacting the ability of the study committees to carry out their work, both completed surveys. The Cities' Compliance with the Americans with Disabilities Act (ADA) Study Committee, led by Jim and Stephanie DeBenedet, hopes to soon make visits to facilities that are currently closed, followed by proposing consensus questions to membership in time for final approval at the 2022 Annual Meeting. Commissions and Boards Study Committee, led by Patricia Hoffman and Barb Luck, was able to analyze responses to their surveys, as well as research other information available online. They presented the resulting consensus question at the Annual Meeting. Plan to attend the Equitable Representation Study consensus meeting on May 24 (see more information on page 1)!

Donna Peterson recommended that the Board enhance efforts to reach out to young people, making them aware of the relevance of our mission and activities to their lives. Much of the following discussion revolved around a proposed award program for high school students. Mindy Greiling reminded us that advocacy is most effective when many people voice their positions directly to decision makers. A successful resolution in favor of organized trash collection in Roseville can be followed by advocacy in Falcon Heights and Lauderdale.

While we'll miss seeing Board Secretary Jim DeBenedet, At-Large Board Member Stephanie DeBenedet, Action/Advocacy Co-chair Priscilla Morton, and Voter Service Chair Karen Lake at monthly Board meetings, we know that they'll be using their considerable skills in other League venues.

Long-time Leaguers Jim and Stephanie also have a long-time history of service to LWV of Roseville Area and its members, and through League, to our cities. Following up on the ADA once again puts Roseville Area in the forefront of an important issue.

Being an Action/Advocacy chairperson means watching what issues are coming to the fore in each of our five cities, advancing the goals of LWVUS and LWVMN, and doing it all while adhering to LWV policies and procedures. We thank Priscilla for keeping us all informed and for her passionate encouragement to advance the issues we care so much about.

When Karen agreed to "one more year," she couldn't have known all that the 2020 election year would entail. Always quick to credit the work of others, she was the stabilizing force behind a challenging effort, working with LWVMN and the Minnesota Secretary of State's Office, among others. Her post office must know her well, having accepted many packages of election materials for community housing and organizations.

### **Burdens Borne**

"They carried their own lives. The pressure was enormous." — Tim O'Brien, The Things They Carried
You may have read Tim O'Brien's almost meditative novel about the soul-destroying fear, violence, brutality, and ambiguity of the Vietnam War, The Things They Carried. One motif O'Brien uses repeatedly to frame the events in the story is a noting of the actual things a soldier carried. They carried the things any person needed to live—rations, water, and dry socks in their heavy packs. They carried the things a soldier needed to live—ammunition, weapons, a radio. So many pounds dedicated to causing or preventing death. They carried the things a spirit needed to survive—letters, photographs. They carried the intangibles that really weighed them down—loneliness, a yearning for a girlfriend and the normal life of youth, a yearning for their lost innocence, love, hate, and FEAR.

Photographer Amber N. Ford gives us another perspective on things carried. In her project, "Mistaken Identity," she focuses on the ordinary items held by Black men, women, and children when they were killed by police. Her images are featured in an essay by Allissa V. Richardson, "It Wasn't a Gun," in the December 2020 issue of *The Atlantic* (<a href="https://www.theatlantic.com/magazine/archive/2020/12/amber-n-ford-mistaken-identity/616927/">https://www.theatlantic.com/magazine/archive/2020/12/amber-n-ford-mistaken-identity/616927/</a>). (They can also be viewed at her website: <a href="http://www.ambernford.com/personal-projects#/mistaken-identity/">https://www.ambernford.com/personal-projects#/mistaken-identity/</a>) The items are exemplars of what shooting victims were carrying, selected from things actually owned and used by Ford, her friends, or family. They are mundane items—a hairbrush, a cell phone, a key ring, or toys—tangible items from daily life. She created the images by "scanning the objects with the scanner's lid open in a dark room," creating a stark black background. Her presentation was intentionally "severe and hinted at the colorless void that emerges when a loved one dies."

Like soldiers in Vietnam, Blacks in the United States of America, and particularly the young men, carry many layers of things. While they do not have to carry items of sustenance except by choice, they, too, bear intangible burdens—racism, negative stereotypes, generational trauma, FEAR.

The US pulled out of Vietnam in 1973 and the war ended in 1975. The experiences of brutality and pointless violence still haunt so many. Derek Chauvin was recently convicted of murder...one case among so many; the list unfinished. Killings of people of color by law enforcement have not ceased; the traumas continue to accumulate.

They have been saying on the news of late that at nearly 20 years the war in Afghanistan is the United States' longest war. But is it?

### **Voter Services Update**

The Voter Services Committee offered area high schools voter registrations when seniors picked up graduation caps and gowns. Schools were also provided eligibility requirements for students registering and information on how to register online. Tartan High School accepted the offer and Marcia Cheney, Gladys Jones, Karen Lake, and Florence Sprague volunteered May 13-14, with 111 students taking advantage of the opportunity.

A Ramsey County grant to fund multiple partners for civic engagement work, especially in underserved neighbor-

hoods, was offered to various community groups. LWV of Roseville Area Voter Services has committed to supporting grant activities identified and/or managed by several organizations who may receive a Ramsey County grant award, expected to be announced by June of 2021. Requests via eBlasts may be forthcoming for LWV of Roseville Area members to volunteer for specific activities throughout this summer and fall which would be opportunities for short-term endeavors to advance voter registrations and education.

### We Support Organized Trash Collection in our Five Cities

We understand the City of Roseville is going to consider the issue of organized trash collection. The League of Women Voters of Roseville Area, an organization with an interest in public services, including their cost and protection of the environment, strongly supports this initiative.

Among the many issues we have studied and adopted positions on, we have, since 1985, had a position in favor of organized trash collection. Furthermore, we updated our position in 2010 and also have reconsidered our position on this issue at every annual meeting of our membership and remain consistently in support of organized trash collection as a means to lower the cost of such service, reduce traffic in our neighborhoods, provide for the environmentally responsible disposal of trash, and reduce wear and tear on our city streets.

In 2012, the Roseville's Public Works, Environment, and Transportation issued a resolution to the council to follow the state-authorized procedure to implement a system of organized trash collection. That resolution included several goals to be considered including:

- 1. **Economic** Ensure the lowest possible uniform rate structure for residents, transparency in rate structures, assurance that city costs will be revenue neutral, and less wear and tear on residential streets thereby reducing the city's maintenance requirements.
- 2. **Environmental** Assure waste is directed to resource recovery facilities for highest and best reuse, to meet mandatory waste reduction goals, and minimize noise and air pollution.
- 3. **Service** Provide for a uniform range of collection options such as size of container and collection of large items and yard waste, credit for extended vacations or seasonal residency, maximize efficiency in solid waste collection, and improved neighborhood aesthetics due to fewer waste collection days.
- 4. **Better Management** A better process for data collection allowing better management for the City, individuals, and haulers.
- 5. **Safety** Fewer trucks on residential streets with less impact on neighborhood livability and safety.
- 6. **Better Planning** Collection of better and more uniform data on waste generation and service delivery.
- 7. **Hauler Impact** Consider existing market share to minimize impact to local haulers.
- 8. **Quality of Service** A fair and open process for customer satisfaction.

Since this was last considered by the City Council, an increasing number of Minnesota cities have adopted organized trash collection as the preferred method of collecting trash for the reasons stated.

We ask all members who live in Roseville to contact the Mayor and City Council to urge them to adopt a method of organized trash collection and disposal that meets all or significantly all of these goals as soon as possible consistent with state statutes.





### **Tiny Homes**

A couple of LWV of Roseville Area members were present at the Open House for TINY Homes at a local church in Maplewood on April 16. This is an innovative enterprise throughout parts of the country to house homeless people. Their purpose: "Settled (which is a non-profit organization) activates and equips faith communities to pursue 'Home With the Homeless' through sustainable housing, purposeful work, and supportive community."

They are focused on community first: social belonging; truly affordable, sustainable homes; being a neighborhood asset; having a support system; and the residents having purposeful work.

These homes on wheels (built by church volunteers) are small but remarkable! They are small communities (six or more hous-

es) that are usually placed in a circle and two of the small houses are occupied by supportive, assistive volunteers, some who have sold their homes and live in this circle.
